Application in the Standard Form are invited from the candidates who are permanent residents of Meghalaya and have passed in Higher Secondary (10+2) (Science Stream) or any other equivalent examination for admission to B.V.Sc & A.H. Degree Course during the session 2010– 11 against the seats to be allotted by North Eastern Council. Nominations of selected candidates in order of merit are subject to availability of reserved seats.

Application form duly filled in is to be enclosed along with crossed I.P.O. of Rs.10/- (Rupees Ten) only drawn in favour of Director of A.H. & Veterinary, Meghalaya, Shillong, payable at the G.P.O., Shillong. **Last date for submission of application form is on the 18<sup>th</sup>. June 2010** at the Office of the Director of A.H. & Veterinary, Shillong and the Office of the Joint Director of A.H. & Veterinary Tura (for candidates from Garo Hills who wish to appear the Screening at Tura). **Screening Test shall be conducted on the 25th. June 2010 at 10:30 A.M. in the Office of the Director of A.H. & Veterinary, Lumdiengjri, Shillong and Office of the Joint Director A.H. & Veterinary, Tura.** Travelling expenses for the interview will be borne by the candidates appearing for interview.

**EDUCATIONAL QUALIFICATION:**

1. Student must have passed HSSLC (Sc)/Equivalent Examination from any recognised Board of Higher Secondary Education/University in India with Physics, Chemistry & Biology with a minimum of 50% aggregate in Science. If marks obtained in PCB are identical the merit will be determined by considering the marks obtained in English.

**AGE LIMIT :**

Candidates should not be less than 17 years and not more than 21 years of age as on 1.6.2010. The upper age limit is relax able by 3 years in case of candidates belonging to Schedules Tribe and Schedules Caste.

**RESERVATION:**

From the numbers of seats allotted by the NEC to the state of Meghalaya, the reservation of seats shall be based on the existing policy of the Government of Meghalaya.

No application will be considered without attested copies of Mark sheets of the qualifying Examination and Certificates.

I.P.O. issued before 1<sup>st</sup>. June 2010 will not be accepted.

Non Tribal Students are to furnish P.R.C. issued by the competent authority without which their application will not be considered.
