With reference to the above cited subject, it is stated that the Board has conducted an inspection of the M/s Rayman Circus which was camped at Elahi Talab, Maudaha, Haripur, Kanpur as directed by the Hon'ble High Court of Delhi vide order dated 14.08.2020 and 20.08.2020 by team authorized by the AWBI including representatives from petitioners i.e. PETA and FAIPO.

It is brought to your notice that the Board has issued registration certificate for Horses-2, Dogs-10, Macaw-2, Cockatoo-3 vide letter dated 02.01.2019. It was informed by inspection team that you even after repeated request failed to show any animals and stated the all the animals have been handed over to People for Animal, Haryana but completely refused disclose the location of the animals for inspection or give any name or proof of the same. Also, you did not allow the representative of petitioner to enter into the premises which is a clear violation of the Hon'ble High Courts direction. A copy of the inspection report is attached herewith for your Information.

In view of the breach of the condition of registration under Performing Animals(Registration) Rules, 2001 by not allowing the entry of the authorized personal and deliberately concealing the location to the animals to avoid inspection and committing an offence under section 3 and 26 of the P.C.A. Act, 1960. The Animal Welfare Board of India under the provisions prescribed in the Performing Animals (Registration) Rules, 2001 hereby cancels the performing animals registration Certificate issued to M/s Rayman Circus under the Performing Animals (Registration) Rules, 2001.

You are hereby required to immediately surrender all your animals to the State Animal Husbandry Department for rehabilitation and submit a comprehensive explanation to all the observations made in the Inspection Report. Also, show why the board should consider giving performing animals registration Certificate and your animals to you again in future, within 15 days of the receipt of this communication, failing which you shall not have any right whatsoever for hearing and re-registration under this Performing Animals (Registration) Rules, 2001 or any other rules made under PCA Act, 1960. The Animal Welfare Board of India shall be free to take any such action as it may consider proper and necessary for the welfare of the animals.


