With reference to the subject cited above, I am furnishing herewith the information as sought for under the *RTI (Right to Information) Act, 2005* concerning Directorate of Animal Husbandry & Veterinary Department as per details below :-

1.	How many employees are there in Nayapara P.O. Pedaldoba branch of Tikrikilla Block of Animal Husbandry.	There are only 2 (two) nos. of employee: (i) Veterinary Assistant : 1 (one) No. (ii) Chowkidar : 1 (one) No. under <b><u>Pedaldoba Veterinary Aid Centre.</u></b> The Aid Centre falls under the establishment of Sub-Divisional A.H. & Veterinary Officer, Dadenggre, West Garo Hills. The infrastructure of above mentioned Aid Centre is in a very bad shape. The building/house itself is in a dilapidated condition with no basic amenities like no water supply and no power supply which is very much required by the employee to carry out his duties. Therefore, as per the order by the Director of A.H. & Veterinary Department, Shillong, the service of the Veterinary Assistant is being utilized in the newly started Poultry Breeding Farm at Phulbari on deployment. However, the Chowkidar is stationed there itself to look after whatever the department's property



		left. The vaccination/treatment, sample and other departmental activities are being covered by the officers and staffs of Belguri Veterinary Dispensary and Tikrikilla Veterinary in addition to their own duties.
2.	How many fund has been released for medicine and other equipment from 2016 till now.	There is no separate released of fund for Pedaldoba Veterinary Aid Centre specifically for the purchase of medicine and other equipments. The small amount of fund for purchase of medicines, materials, stationeries and equipments etc released to together along with other Veterinary Aid Centres under Sub-Divisional A.H. & Veterinary Officer, Dadenggre, West Garo Hills. Hence, the question of providing the fund only Pedaldoba Veterinary Aid Centre w.e.f. 2016 till date does not arise.
