## A. General Terms and Conditions:

- i) The bidders may inspect the items (vehicles) on predetermined dates and satisfy themselves about the items they are bidding for as the items conditions are on "AS IS WHERE IS" basis.
- ii) The valid copy of ID proof to be enclosed (self attested copy of valid PAN, Voter ID/Aadhar Card etc.)
- iii) For Persons/Firms/Dealers/private individual who are engaged in trade or profession in the State of Meghalaya, *GST* registration certificate to be enclosed alongwith the Tender documents.
- iv) For Govt. employee of the State of Meghalaya, Govt. I.D. Proof to be enclosed alongwith the Tender documents.
- v) In case of Non-Tribal, the bidder has to produce the Trading Licence issued by any of the District Councils *(viz., KHADC, JHADC & GHADC)* of the State of Meghalaya.
- vi) The amount must be quoted in figures as well as in words.
- vii) The bid shall be awarded in favour of the bidder quoting the highest price.

- viii) All bidders/tenderers should submit alongwith a Demand Draft as Earnest Money at 10% of the reserve price to be submitted in favour of Director of Dairy Development, Shillong without which, tender will be void.
- ix) The Earnest Money Deposit (EMD) of unsuccessful bidders shall be reimbursed within one month of the tender date, without any interest Cheque/Money Order/Cash shall not be accepted. The EMD deposit shall not attract any interest.
