Application in prescribed form are invited from indigenous inhabitant and permanent residents of Meghalaya for admission to BVSc & A.H Course for the session 2006-07 against reserved seats allotted by N.E.C.

The applicants who have passed the 10+2 level examination from a recognized Universities/Board with Physics, Chemistry, Biology and English with a minimum of 50% marks in aggregate in Science stream will be eligible for the interview.

Candidates should not be less than 17 years of age .

Application form can be obtained from office of the undersigned on working days w.e.f. <u>1.6.2006</u> and the **last date for submission of complete application is upto 3 p.m. on or before <u>15.6.2006</u>** at the Directorate of A.H & Veterinary Department, Shillong.

Application forms can also be obtained from and submitted to the office of the Joint Director A.H. & Veterinary Department, Tura on or before the specified date as above.

No application form will be received after 16.6.2006.

Application form should be accompanied with the following documents :-

- 1. Attested copy of mark sheet of SSLC & HSSLC Examination.
- 2. Character Certificate from the Head of Institution last attend and certificate of having passed the qualifying examination.
- 3. Attested copy of SSLC Admit Card.
- 4. Three copies of passport size photograph duly attested by Gazetted Officers.
- 5. ST/SC & OBC Certificate from competent authority.
- 6. Permanent Residential Certificate for general category candidate.
- 7. A crossed IPO of Rs. 5/- for SC/ST/OBC candidate and Rs. 10/- for others payable to Director A.H & Veterinary Meghalaya, Shillong. IPO purchased **before** <u>1.6.2006</u> will not be accepted.

Selection of candidates will be made strictly on the basis of their merit and it will be determined on the marks obtained in Science stream. If aggregate marks obtained in Science stream is identical, the merit will be determined by considering the marks obtained in English.

Reservation of seats will be based on the existing policy of the Government of Meghalaya.

The Candidates who fulfill the norms with 50% and above are required to appear for Personal Interview at the Directorate of A.H & Veterinary Department, Shillong on $\underline{24.6.2006}$ at $\underline{11}$ A.M. with all original certificate/testimonials for necessary verification.

No individual intimation will be made for this purpose. Candidate should appear for the interview at their own expenses, any candidate who failed to appear for the interview on the specific date and time will not be considered for selection under any circumstances.

List of selected candidates based on merit will be displayed in the Office Notice Board and will also be published in the local newspaper.

Allotment of seats will be made as per the availability of seats in the Colleges/Universities and admission is also subject to the norms fixed by the respective Universities.

Selected Candidates will have to produce physical fitness certificate from Civil Surgeon before joining the course.
