Online Application in prescribed format for admission to B. V. Sc & A. H Degree Course during the session 2026-27 against seats allotted to the State Government at College of Veterinary Science in Assam, Mizoram & Nagaland are hereby invited with effect from 25th July 2026, up to 3rd August 2026, till 5:00 P.M. For details, visit the Department website <http://www.megahvt.gov.in>.

Eligibility Conditions:

1. Only candidates who are indigenous inhabitant or Permanent Residents of the State and have passed 10+2 level examination from a recognized University or Board of Authority in the subjects of Physics, Chemistry, Biology/Biotechnology and English and obtained 50% marks in aggregate for General and 47.5% for SC/ST and qualifying NEET UG 2026 are eligible to apply.
2. They should complete the age of 17(seventeen) years on or before 31st December 2026. The upper age limit for candidates is 25 years as on 31st December 2026. However, provided that this upper age limit shall be relaxed by 5(five) years for the candidates of SC/ST.
3. Applicants should be medically fit.
4. Application Form without NEET UG 2026 (RESULT SHEET) will not be considered under any circumstances.
5. Selection of candidates, who are otherwise medically fit and eligible will be ranked as per their NEET Score in their respective categories. In the event that two or more candidates obtained the same NEET Score, then the marks obtained in PCB (Physics, Chemistry, Biology/Biotechnology) will be the deciding factor for ranking. In respect of candidates belonging to Scheduled Castes/ Scheduled Tribes, the minimum marks shall be as prescribed to such categories and subject to Reservation Policy of the State Government applicable in this regard.
6. The list of candidates eligible for screening/ counselling will be displayed in the department website/Notice Board.
7. The date of screening/ counselling will be notified later.
8. The final list of applicants selected for nomination under all categories and the waiting list for each such category will be displayed in the Notice Board of Directorate of A. H. & Veterinary, Meghalaya, Shillong/ Office of the District A. H. & Veterinary Officer, Shillong/ Nongstoin/

Note: Physical Disability:

The admission to BVSc & AH degree course shall not be allowed in the case of candidates suffering from following disabilities.

- a) Disability of total body (including chest or spine) more than 50%.
- b) Disability of lower limb of more than 50%
- c) Disability of Upper limb.
- d) Visually handicapped and those with hearing disability.
- e) Progressive diseases like myopathies etc.
- f) Disabilities which otherwise would interfere in the performance of the duties of a veterinarian.

The disability of the candidate should be certified by a Medical Board duly constituted and authorized by the Government. The medical board shall comprise of at least three specialists out of which two shall be of the speciality concerned. The candidate should present him or her-self before the Medical Board and the last valid disability certificate of the candidate from a Medical Board shall not be more than three months old from the date of submitting his or her certificate for claiming seat under disabled category.
