**TENDER DOCUMENT**

Sealed Tenders affixing non-refundable Court Fee Stamp of ₹250/- (Rupees Two Hundred Fifty only) are invited from reputed Manufacturers, Registered / Authorized Dealers for “Empanelment as Supplier(s) of Veterinary Patent Medicines at the Animal Husbandry & Veterinary Department, Meghalaya, Shillong” as per following details and Terms and Conditions:

**1. NATURE & SCOPE OF WORK:**

1.1 “Empanelment as Supplier(s) of Veterinary Patent Medicines at the Animal Husbandry & Veterinary Department, Meghalaya, Shillong” as per terms and conditions mentioned herein.

**2. ELIGIBILITY CRITERIA:**

2.1 Bidder intending to bid shall fulfill the following eligibility criteria:

2.1.1 Shall be reputed Manufacturers, Registered/Authorized Dealers of Veterinary Patent Medicines having at least 3 (three) years’ experience in supplying such items to the AH & Veterinary Department, Government of Meghalaya.

2.1.2 Should have proven Financial Status capability, proof of which shall be in the form of last 5 years’ balance sheet / audited statement of accounts.

2.1.3 Should not have been banned / blacklisted / temporary suspended by any Government Department / Organisation.

**3. INSTRUCTIONS TO BIDDERS:**

3.1 The tender document can be obtained from the Directorate of A.H & Veterinary or downloaded from <http://megahvt.gov.in> on payment of ₹1000/- (Rupees one

- thousand only**) by DD/IPO drawn in favour of “The Director of AH & Veterinary, Meghalaya, Shillong” and payable at Shillong which is non-refundable.
- 3.2 The Bidder qualifying the above criteria at Sl. 2 shall submit the bids in **TWO SEPARATE SEALED ENVELOPES**.
- 3.3 **Sealed Envelope (A)** which is the “**TECHNICAL BID**” inside which all documents morefully described at Sl. 4 of this document shall be kept.
- 3.4 **Sealed Envelope (B)** which is the “**FINANCIAL BID**” inside which the format duly filled up as per **Annexure-IV** is to be kept.
- 3.5 Both Envelope (A) and Envelope (B) must then be placed in one larger **sealed Envelope (C)** which is the “**MAIN ENVELOPE**” and superscribed as “**Empanelment as Supplier(s) of Veterinary Patent Medicines at the Animal Husbandry & Veterinary Department, Meghalaya, Shillong**”. The same is to be addressed to the Director of Animal Husbandry & Veterinary, Lumdiengjri, Meghalaya, Shillong – 793002.
- 3.6 The **name, address, email and contact number of the firm** submitting the Tender must appear distinctly on **every sealed envelope**.
- 3.7 The **sealed “MAIN ENVELOPE” shall be dropped at the designated box** in the office of the Director of AH & Veterinary, Lumdiengjri, Meghalaya, Shillong-793002.
- 3.8 Unsealed materials will not be accepted. Bidder shall be responsible for proper sealing of the Bid Documents to prevent accidental opening.
- 3.9 Bids must be written in English.
- 3.10 Price should be quoted in Indian Rupee both in figures and in words.
- 3.10 Price should be quoted in Indian Rupee both in figures and in words.
- 3.11 The **last date of receiving the Tender** is on the **25<sup>th</sup> October 2022** upto **2:00 PM** and will be **opened on the same day** at **2:30 PM** in the **Office Chamber of the Director of A.H. & Veterinary Meghalaya, Shillong**. Tenderers or their representatives if desired may be present at the time of opening of the Tender.

- 3.12 Financial Bid will be opened at a later date to be intimated accordingly.
- 3.13 Any Bid(s) **received after the deadline for submission will be rejected outright** and bidder will have to collect their bid document at their own expenses. In case any unscheduled holiday occurs on the prescribed closing/opening date the next working day shall be the prescribed date of closing/opening of the Tender.
- 3.14 All Tenders **should be accompanied with an Earnest Money Deposit** which shall morefully described at Sl. 6 of this document.
- 3.15 **Every sheet of Tender Document, complete in all respect, and all Forms/ Annexures/ Enclosures, shall be signed** by the person/persons duly authorized to sign on behalf of the applicants as a token of having understood and accepted all terms and conditions mentioned in Tender Document. Any /all corrections made in the offer shall be duly authenticated by the signature of the authorized signatory. **Tenders received without signature with seal of the firm(s) on all pages will be rejected.**
- 3.16 The **submitted documents are not transferable** and the seal and signature of the authorized official of the firm(s) must appear on all the papers and envelopes submitted.
- 3.17 **Clarification on Tender document:** Applicants may seek clarification on the tender document **within 10 (ten) working days** from the date of appearing of advertisement in local dailies. **Any request for clarification must be sent by email to the Director's email address ONLY (meghvety01@gmail.com).**
- 3.18 At any time prior to the date of submission of Tender, Director of AH & Veterinary, Meghalaya, Shillong, may, for any reason, either of its own or in response to a clarification from an interested firm, modify the NIT by an amendment / corrigendum. **Any such amendment / corrigendum as deemed necessary by the Director, AH & Veterinary Department, will be notified through the Department's website only.** Interested firms are advised to check the Department's website every now and then for any amendment / corrigendum.

- 3.19 In order to provide reasonable time to take the amendment into account in preparing the documents, Director of AH & Veterinary, Meghalaya, Shillong may extend the date and time for submission of Tender.
- 3.20 The **Director of AH & Veterinary, Meghalaya, Shillong reserves the right to accept, reject or partially accept any Tender or any items without assigning any reasons thereof.**
- 3.21 The Director of AH & Veterinary, Meghalaya, Shillong **is not bound to accept the lowest quotation / highest discount, offered.**
- 3.22 **Conditional Tender not acceptable:** All the terms and conditions mentioned herein must be strictly adhered to by all the firms. Conditional Tender shall not be accepted on any ground and shall be rejected straightway. Conditions mentioned in the Tender submitted by vendors will not be binding on Director of AH & Veterinary, Meghalaya, Shillong.

#### **4. DOCUMENTS TO BE SUBMITTED WITH THE TENDER:**

##### **4.1 The following documents are to be enclosed with the Tender in Sealed Envelope (A) which is the “TECHNICAL BID” otherwise the bid will not be considered:**

- 4.1.1 **Declaration** as per format at Annexure I.
- 4.1.2 **EMD in the form of Demand Draft** which is morefully described at Sl. 6 of this document.
- 4.1.3 **Brief history/background** of the Firm along with complete **details of personnel authorized to take up the project.**
- 4.1.4 **Similar assignment done by applicant during the previous three financial years** which is to be supported by documents. A NIL declaration may be submitted in the event of bidder(s) not having the experience.
- 4.1.5 Details of **Financial status of applicant** in the form of last 5 (five) years' balance sheet / audited statement of accounts.
- 4.1.6 **Compliance Certificate** as per format at Annexure-III.

- 4.1.7 **Distributorship Certificate:** Tenders submitted by authorized dealers for a particular Company should furnish necessary documents as proof of being authorized dealer(s).
- 4.1.8 Authenticated copy of the **Product Catalogue(s)**
- 4.1.9 Authenticated copy of **Price list(s) in hard and soft copy** (*in excel or word file only*)
- 4.1.10 Authenticated copy of **valid Drugs License issued by the Competent Authority.**
- 4.1.11 Authenticated copy of **valid GST Registration Certificate.**
- 4.1.12 Authenticated copy of **valid Professional Tax Clearance Certificate.**
- 4.1.13 Authenticated copy of **Income tax clearance or Scheduled Tribe Certificate** by Tribal Firm(s).
- 4.1.14 Authenticated copy of **valid Trading License Certificate for Firms/ Suppliers other than Scheduled Tribe of the State.**
- 4.1.15 Authenticated copy of **valid PAN/ TIN.**
- 4.1.16 **Proof of payment of Tender document** in the form of a Receipt from the Cashier of the Directorate of AH & Veterinary or DD/IPO drawn in favour of “The Director of AH & Veterinary, Meghalaya, Shillong” and payable at Shillong

**4.2 The following documents are to be enclosed with the Tender in Sealed Envelope (B) which is the “FINANCIAL BID” otherwise the bid will not be considered:**

- 4.2.1 **Financial bid** as per format at Annexure IV duly filled up and signed by authorized person of firm (*Soft copy also to be submitted in word or excel file only*)

**5. PERIOD OF VALIDITY:**

- 5.1 The period of contract shall **initially be for a period of one year with effect from date of issue of contract order** and is extendable for one more year on satisfactory performance, under the same terms and conditions or with such amendments as may be mutually agreed to, and also subject to the necessary approval of the Competent Authority. The entire period of contract shall not exceed three years, unless otherwise notified by the Director of AH & Veterinary, Meghalaya, Shillong.
- 5.2 Should the Director of AH & Veterinary deem necessary to extend the period of contract, the Bidder's consent for the same shall be made in writing. On agreement of extension, the Security Deposit provided shall also be suitably extended. A Bidder may refuse the request without forfeiting the Security Deposit.

#### **6. EARNEST MONEY DEPOSIT(EMD):**

- 6.1 The Bidder(s) shall furnish, as a part of its bid, Earnest Money of **Rs.1.00 Lakh** for general category bidder(s) & **Rs.50.00 thousand** in case of tribal bidder(s).
- 6.2 The Earnest Money is required to protect the Director of Animal Husbandry & Veterinary against the risk of Bidder's conduct, which would warrant the security's forfeiture.
- 6.3 The Earnest Money shall be in the form of **Demand Draft pledged in favour of the Director Animal Husbandry & Veterinary, Meghalaya payable at Shillong**. Under no circumstances cash, cheque or any other mode of payment will be accepted as Earnest Money.
- 6.4 **Any bid not accompanied by Earnest Money will be rejected.**
- 6.5 Unsuccessful Bidder's Earnest Money will be discharged or returned as promptly as possible as but not later than ninety (90) days from the date of furnishing of contract by the successful bidder.
- 6.6 The successful Bidder's Earnest Money will be released upon the Bidder signing the contract and depositing of Security Deposit.
- 6.7 The Earnest Money shall be forfeited:

6.7.1 If a Bidder withdraws his/ their bid during the period of bid validity specified by the Bidder on the Bid Form; or

6.7.2 In case of a successful Bidder, fails to sign the contract; or

6.7.3 In case any Bidder alters/ modifies their tenders after expiry of the deadline for receipt of tender till the date of validity of tenders.

## **7. TERMS & CONDITIONS:**

7.1 **Prices quoted should be in Indian Rupees only** and price quotations should be submitted as per format given in Annexure–IV.

7.2 The purpose of the tender is to **empanel all ELIGIBLE reputed Manufacturers, Registered/Authorized Dealers** as Supplier(s) of Veterinary Patent Medicines for the AH & Veterinary Department. **The Financial quotation will be assessed on the basis of the discount offered by the Manufacturers or Registered/ Authorized Dealers.** The Tenderer(s) quoting at the highest discount for any particular company(s) will be empaneled for that particular company(s). **Those Manufacturers, Registered/Authorized Dealers whose quoted discount fall short of the highest, but are willing to give the same level of discount subsequently, would also be eligible for empanelment.**

7.3 The rates should be quoted **inclusive of all taxes and transportation upto destination.** Taxes to be charged if any should be quoted clearly against each of the taxable item.

7.4 The firms shall indicate **discount offered, if any,** on catalogue price in clear/visible figures as well as in words and shall not alter/overwrite/make cutting in the quotation. In case of a mismatch, the discount offered in words will prevail. Usage of “White ink” to erase and then rewrite the discounts will not be accepted. Bidders are advised to strike out wrong entries and rewrite clearly beside them. In such cases, the bidder shall have to sign and place their official seal for every corrected entry.

7.5 **Special discount(s), if any,** applicable to supply at Institutions/ Government supply, should be quoted separately.



- 7.6 If there is **any change in catalogue price offered** due to **statutory levy increases** like taxes and duties by original manufacturer, the vendors need to submit the new catalogue with an application to the Director of AH & Veterinary, Meghalaya, Shillong. The same will be allowed on submission of documentary evidence. However, the discount offered shall remain same as per original rate.
- 7.7 **Distributorship Certificate:** Tenders submitted by authorized dealers for a particular Company should furnish necessary documents as proof of being authorized dealer(s) against their Principals/ Companies otherwise their Tender will not be entertained. Tenderers shall hold responsibility on any infringement of other Manufacturer's products.
- 7.8 **Authenticated copy of the Product Catalogue** should be submitted **otherwise their Tender will not be entertained.**
- 7.9 **Authenticated copy of Price list** should be submitted both in hard and soft copy (in excel or word file only) **otherwise their Tender will not be entertained.**
- 7.10 The firms must attach a copy of **valid GST Registration Certificate**, failing which the quotation will be rejected.
- 7.11 All Tenders must be accompanied with the following documents failing which the Tender will not be considered:
- a) copy of **valid Professional Tax Clearance Certificate**
  - b) copy of **valid PAN/ TIN**
  - c) **Scheduled Tribe Certificate** by Tribal Firm(s), and
  - d) **Valid Trading License Certificate for Firms/ Suppliers other than Scheduled Tribe of the State** of Meghalaya, issued from the respective District Councils of the State
- 7.12 Tenderer dealing with Chemicals, Drugs, Vaccines should furnish a **valid copy of the drugs license issued by the Competent Authority.**
- 7.13 Preference will be given to Manufacturers or Registered/Authorized Dealers having **proven Financial Status capability** and having **experience in supplying Veterinary**

**Patent Medicines for the past 3 (three) financial years to the AH & Veterinary Department, Government of Meghalaya.**

7.14 **Successful bidder(s) will be officially informed.** On award of the contract, the successful bidder(s) should execute an agreement with Directorate of Animal Husbandry & Veterinary on non-judicial stamp paper of ₹100/- (Rupees one hundred) while incorporating all the Terms and Conditions of the contract. This shall be at the expense of the supplier and shall be executed within 15 (fifteen) days of final acceptance of the Tender.

**7.15 Successful bidder other than Scheduled Tribe of the State of Meghalaya has to obtain Trading License from the respective Autonomous District Councils of the State of Meghalaya at their own cost.**

7.16 **No supply order shall be affected unless the deed of contract is executed and the security money is deposited.** If the security money is not deposited within the time fixed for the purpose, the amount deposited as earnest money shall be forfeited and credited to the Government. The firms who fail to execute the Agreement after the rate have been approved, shall have to make good the loss caused to Government through their inability, default on delay caused to comply with terms and conditions of the Tender Notice and in the first instance their earnest money shall remain forfeited to the Government.

7.17 Once the contract is made the **Supplier shall have to maintain a regular supply of items** when ordered for. If the supplier fails to maintain a regular supply of the approved articles against any order, his contract shall be liable to be terminated and the security deposit forfeited to Government.

7.18 The supplier shall have to **supply the articles indented for within 1 (one) month** from the date of placing orders, failing which the orders will automatically be treated as cancelled and their earnest money shall be forfeited and the excess value paid thereof will be deducted from the security deposit. However, the Indenting Officers may extend the time of supply on receipt of a specific request from the Suppliers for their inability to supply any item on some genuine ground.

- 7.19 **Loss, Damage and Shortage:** The required Veterinary items must be supplied to the Indenting Officer at the risk of the Firm / Supplier(s) who shall be responsible for any leakage, damage or loss in transit. Payment shall be made for materials received in good conditions only and no articles will be received which are damaged in any form. Any damage or shortage noticed on delivery, the same must be replaced within 7 (seven) days after intimation.
- 7.20 **Payment:** No advance payment shall be made by the Department to the awardee. 100% payment within 30 (thirty) days from date of delivery and only after the Provisional Acceptance Certificate (PAC) is received duly certifying that the items have been received in good condition as per the specifications of the contract.
- 7.21 **Procuring Entity's right to vary quantity:**
- 7.21.1 At the time of award of contract, the quantity of Drugs/ Vaccines, originally specified in the bidding documents may be increased or decreased. There will not be any minimum quantity guaranteed against bid quantity. The bid quantity is only indicative. Actual purchase can be more or less than the bid quantity based on actual consumption by the Department.
- 7.21.2 If the procuring entity does not procure any subject matter of procurement, or procures less than the quantity specified in the bidding documents due to change in circumstances, the bidder shall not be entitled for any claim or compensation.
- 7.22 The **contract can be terminated at any time by giving one month's notice** from either side. However, if the selected supplier(s) fail(s) to comply with the terms and conditions of the contract, then the Director of AH & Veterinary is empowered to terminate the contract with short notice of one week.
- 7.23 If the rate quoted is signed at a lower price with any other organization subsequent to award of contract by Director of AH & Veterinary, the firm(s) must supply the items/materials under the rate contract at those rates.
- 7.24 **Force Majeure:** If the performance of the obligation of either party is rendered commercially impossible by any of the events hereafter mentioned that party shall be under no obligation to perform the agreement under order after giving notice of

15(fifteen) days from the date of such an event in writing to the other party, and the events referred to are as follows:

7.24.1 Any law, statute or ordinance, order action or regulations of the Government.

7.24.2 Any kind of natural disaster, and

7.24.3 Strikes, acts of the Public enemy, war, insurrections, riots, lockouts, sabotage.

7.25 **Taxes and duties:** The supplier shall be entirely responsible for all taxes and duties etc. incurred until completion of the contract. TDS wherever applicable shall be deducted at source as per extant laws.

## **8. SECURITY MONEY**

8.1 Within 15 (fifteen) days of award of contract, the successful bidder shall be required to furnish a security money at the rate to be determined after finalization of Tender.

8.2 The Security Deposit shall be in one of the following forms:

8.2.1 Bank Guarantee, issued by a reputable bank, or

8.2.2 Deposit at Call Receipt in favour of The Director A.H. & Veterinary, Meghalaya, Shillong and payable at Shillong.

8.3 The proceeds of the Security Deposit shall be payable to the Director of Animal Husbandry & Veterinary as compensation for any loss resulting from the Supplier's failure to complete the obligations under the contract.

8.4 Failure of the successful Bidder(s) to sign the Contract and/or furnish the Security Deposit shall constitute sufficient grounds for the annulment of the award and forfeiture of the Earnest Money. In that event, the Director of Animal Husbandry & Veterinary shall have the liberty to award the Contract to the second lowest responsive tenderer.

8.5 The Security Deposit will be released by the Director of Animal Husbandry & Veterinary and returned to the Supplier not later than 90 days following the date of completion of the Supplier's performance obligations under the contract.

## **9. NOTIFICATION OF AWARD**

- 9.1 Prior to the expiration of the period of bid validity, the Director of Animal Husbandry & Veterinary will notify the successful bidder(s) in writing.
- 9.2 The notification of award will constitute the formation of the contract.

## **10. PENALTY CLAUSE**

- 10.1 For non-performance/delayed performance, the following penalties may be imposed on the successful bidder, without assigning any reasons thereof. This is however subject to obtaining of extension in writing from the Director of Animal Husbandry & Veterinary on valid ground before expiry of delivery period:
- 10.1.1 Terminate the contract / purchase order in whole or in part
  - 10.1.2 Forfeiture of Security Deposit
  - 10.1.3 Imposition of penalty @ 5% (five percent) of the total value of the item covered in supply order, per week of delay.
  - 10.1.4 Procurement of the items, in such terms and in such manner, as is deemed appropriate by the Director of AH & Veterinary, Meghalaya, Shillong, items similar to the undelivered items/products and the defaulting supplier shall be liable to compensate Director of AH & Veterinary, Meghalaya, Shillong for any extra expenditure involved towards goods and services obtained.

## **11. RIGHT TO ACCEPT ANY BID AND TO REJECT ANY OR ALL BIDS:**

- 11.1 The Director of Animal Husbandry & Veterinary reserves the right to accept or reject any bid, and to annul bid process and reject all bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or bidders or any obligation to inform the affected Bidder or bidders of the grounds for the Director of Animal Husbandry & Veterinary's action.

## **12. SAVING CLAUSE**

12.1 No suit, prosecution or any legal proceedings shall lie against Bid Inviting Authority or any person for anything that is done in good faith or intended to be done in pursuance of Bid.

### **13. RESOLUTION OF DISPUTES**

13.1 The Director of Animal Husbandry & Veterinary and the Agency/Firm shall make every effort to resolve amicably by direct informal negotiation any disagreement or dispute arising between them under or in connection with the contract, failing which either party may approach a competent court having jurisdiction to resolve the dispute. In connection with this tender, cases, if any, shall be subject to the jurisdiction of competent court at Shillong.

13.2 For resolution of disputes, appropriate legal action shall be initiated in consultation with Law Department, Government of Meghalaya. Relevant sections of Indian laws as amended from time to time shall be applicable and binding on the bidder.
