Tender in sealed covers in connection with supply of 1000 litres capacity Bulk Milk Cooler with 10 KVA Generator set including Erection and Commission, are hereby invited from the manufacturers / suppliers to be received by the undersigned on or before **2nd Sept. 2008**. The Tenders will be opened by and in the office of the undersigned on the same day at about **2 P.M.** Interested Tenderers may like to be present at the time of opening the Tenders. A Court Fee Stamp of Rs. 250/- (Rupees Two hundred fifty) only should be affixed on every Tender.

The following certificates should be attached by the Tenderers alongwith their Tenders failing which Tender will not be considered.

1. Up-to-date Income Tax and VAT clearance Certificate.
2. Original Certificates of Registration as Manufacturers or authorization from the Manufacturers and other authentic documents to support about their financial status, antecedents, past performance etc.
3. The availability of facilities for after sale service and spare parts for the Plant in India should be indicated. The terms and condition for entering into after sale service agreement should be clearly stated.

The envelope containing the Tender should be superscribed with word **"Tender for Bulk Milk Cooler with Generator Set"**.

The rate in Indian Rupees should be quoted, inclusive of all taxes and other incidental charges and delivery should be F.O.R. destination.

The selected Tenderer should furnish guarantee certificate on workmanship and the performance of the equipment for a minimum period of 18 months from the date of supply.

The selected Tenderer shall be responsible for obtaining road permit from the concerned authority.

The undersigned does not bind himself to accept the lowest Tender or to assign any reasons for not accepting any Tender even if duly made.

The selected Tenderers will have to furnish a security deposit of 5% of the order value in the form of Call Deposit to be pledged in favour of the undersigned and the same will be released after completion of supply and installation. Commission should be completed within 45 days from the date of acceptance of the Tender failing which the security deposit will stand forfeited.
