- The Tender should be submitted in the Schedule/Form which will be made available from the Office of the undersigned on payment of Rs.500/-(Rupees five hundred) only. In no case, manuscript form will be accepted.
- 3. Tenders submitted by authorized dealers for a particular Company should furnish necessary documents as proof of being authorized dealer (s) against their Principals/Companies along with Company Price List, otherwise their Tender will not be entertained.
