NOTICE INVITING TENDER


Sealed tender affixing a non-refundable Court Fee Stamp of ₹ 250/- (**Rupees Two Hundred Fifty**) only are invited for supply of Veterinary Non-Patent Medicines, Laboratory Equipments and Appliances/Tools and Agricultural Implements for the year 2020-21 from the Manufacturer, Registered/ Authorized supplier. The last date of receiving the Tenders is on the **5th January 2021** up to **2:00 PM** and will be opened on the same day at **2:30PM** in the Office Chamber of the Director of A.H. & Veterinary Meghalaya, Shillong. Tenderers or their representatives if desired may be present at the time of opening of the Tenders.

All Tenders must be addressed to the Director of Animal Husbandry & Veterinary, Lumdingjri, Meghalaya, Shillong-793002 and supercribed as "**Tender for supply of Veterinary Non-Patent Medicines, Laboratory Equipments And Appliances/Tools and Agricultural Implements**". Full name and address of the Tenderers should be mentioned clearly on the cover.

1. Each Tender should be accompanied with an earnest money of ₹ 20,000/- (**Rupees Twenty Thousand**) only should be deposited by Non-Tribal Firm(s) and ₹ 10,000/- (**Rupees Ten Thousand**) only by Tribal Firm(s) in form of Call Deposit/Banker Cheque/Banker Draft duly pledged in favour of the Director of Animal Husbandry & Veterinary Department, Government of Meghalaya Shillong, without which no tender will be entertained. Earnest Money, deposited in the form of cheque or cash will not be accepted. Each page of the tender document should be signed by the tenderer before submitting the tender. Rates quoted against the item should be quoted in words and figures as well. The tender copy is to be obtained from the Directorate of A.H. & Veterinary Department, Meghalaya, Shillong on payment of ₹ 300/- (**Rupees Three hundred**) only.
2. Preference will be given to those who produce specified quality along with the Tenders. The instruments and appliances should bear the imprint of their maker. In case of costly Laboratory Instruments/Laboratory Equipments etc. only literatures alongwith detailed specification must be enclosed.
3. All Tenders must be accompanied with GST Registration Certificate/Registration No Certificate, Professional Tax Certificate, PAN Card and attested copy of Schedule Tribe Certificate by the Tribal Firm(s) without which no Tender will be considered. All Non-Tribal Tenderers must furnish a valid Trading License from the concern District Councils, without which their Tender will not be entertained.
4. Tenderers quoting rates for weighing scale/balance should furnish certificate from the Controller of Weight & Measures.
5. Tenderer dealing with Chemicals, Drugs etc. should furnished a copy of up to date Drugs License issued by the competent authority wherever necessary.
6. The rates should be quoted F.O.R. Destination. Taxes to be charged if any should be quoted clearly against each of the taxable item.
7. The required Veterinary stores/items must be supplied to the Indenting Officer at the risk of the firm and the Supplier (s) will be responsible for any leakage, damage or loss in transit etc. It may be noted that no articles will be received which is damaged in any form.
8. i) The Earnest Money will be released to the unsuccessful Tenderers.
ii) The Earnest money of successful Tenderers will however be released only when the security deposit required vide para 9 is furnished and deed of contract duly executed and supply made.
9. i) Successful Tenderer has to deposit the security money as admissible and sign the Contract Agreement.
ii) The Security Money will stand forfeited if the supplier fails to adhere to the terms laid down and fails to make supply of the materials not to the specification quoted and terminate the contract without valid reason.
10. Once the contract is made the supplier shall have to maintain a regular supply of items when ordered for. If the supplier fails to maintain a regular supply of the approved items against


any order, his contract shall be liable to be terminated and the security money forfeited to the Government.

11. The Tendered rates once accepted by the Department will remain valid for a period of 2 (two) years or until further orders. The supplier shall have to supply the items indented for within 1 (one) month from the date of placing orders, failing which the orders will automatically be treated as cancelled and their security money shall be forfeited/excess value paid thereof will be deducted from the security deposit. However the Indenting Officers may extend the time of supply on receipt of a specific request from the Suppliers for their inability to supply any item on some genuine ground.
12. The undersigned reserves the right to accept or reject any Tender or any items without assigning any reason thereof and is not bound himself to accept the lowest or any rate or any Tender.


